

Terms and Conditions First Presbyterian Church Colorado Springs Tour to Israel

April 23 – May 3, 2022 \$4,085 Land Only \$1,585 Roundtrip Airfare from Denver (DEN)

This tour is based on rates in effect October 2021 and is subject to change in the event of significant currency fluctuation. This tour is priced on a minimum of 30 paying participants.

Activity Level and Health

The activity level on this tour is moderate. Participants must be in good health and able to walk at a moderate pace, without assistance, for a couple of miles at a time on uneven terrain. Certain sites require climbing multiple flights of stairs that may not have handrails.

Included in the Price

Shared double room in first class and superior tourist hotels; daily meals as indicated in itinerary; transportation and entrance fees to sights; and gratuities.

Not Included in Price

Single room supplement: \$1,375; possible increases in the airline tax/fuel surcharge; additions/changes to standard program; individual transfers; travel insurance; coffee and drinks; excess baggage.

Airline Transportation

The option to purchase round-trip economy air will be made available to tour participants on an individual basis. Group tickets from Denver (DEN) will be made available. Tickets are non-refundable, non-amendable tickets.

Flight Times

Flight times are subject to change by the airlines without advance notice. If this occurs, Footstep Ministries reserves the right to shorten or lengthen the itinerary accordingly and, whenever



possible, you will be notified in writing. If changes necessitate extra overnights, you will be charged \$150 per night per person, single rooms \$250 per night per person.

Reservation and Deposit

A deposit of \$500 per person is required at the time of reservation. The balance is due no later than December 9, 2021. For reservations received after December 9, 2021, payment may also include a \$100 late booking fee per person in addition to any subsequent increases in the price of airfare after December 9, 2021.

Transfers

Group transport between airport and hotel is included. Those who request changes from the standard flight schedule and who do not arrive with the group are responsible for their own airport-hotel transfers.

Luggage

Limit of one suitcase and one carry on per person; porterage is for one suitcase only. Carry-on luggage is the responsibility of passengers.

Cancellation Fees

All cancellations prior to December 9, 2021 will receive full deposit refunds. Footstep Ministries must receive all cancellation and refund requests in writing. A cancellation fee of 25% of tour price will be applied to cancellations submitted after December 6, 2021 and before March 9, 2022; 75% of tour price if received between March 10 and April 1, 2022; and 100% of tour price on or after April 2, 2022. No-shows or cancellations after date of departure receive no refund whatsoever. All cancellation fees are based on the total tour price including all supplements, extensions, upgrades, and additional costs. Flight cancellations are subject to the terms of the respective airline.

Insurance

Tour participants are highly recommended to purchase insurance for trip cancellation, trip interruption, accident, sickness and/or loss of baggage and personal effects. Travel insurance can be purchased by <u>clicking here</u>.

Documentation

U.S. citizens require a valid passport. The traveler assumes complete and full responsibility for and hereby releases FM, Inc. from any duty of checking and verifying any and all passports, visa, vaccination or other entry requirements for each destination, and all safety and security



conditions during the proposed travel. Travel to Israel requires six months of passport validity beyond the return date of the tour.

Statement of Responsibility

Neither FM nor any of its affiliates or subsidiaries shall be or become liable or responsible for any additional expenses of liability sustained or incurred by the tour member as a result of any of the aforementioned causes. FM responsibility to passengers carried in vehicles and aircraft for transfer and excursions and tours is governed by the laws of the respective countries in which the tours take place and no other country. All claims against FM must be made within 30 days of travel and are subject only to the jurisdiction of the courts of the country in which the cause of action arises. The right is reserved to substitute hotels and cruise ships and to alter itineraries. The right is also reserved to cancel the tour prior to departure. If any tour is cancelled prior to the passengers joining the tour, FM is liable for a refund of monies received. FM is not responsible or liable for defaults of those not directly under the control of FM. All tickets and vouchers issued for transportation and services are subject to the terms and conditions under which such transportation and services are provided to the participant by the owners or contractors.

The receipt of your deposit will indicate that you have read these Terms and Conditions, and that you have agreed to them. Prices are subject to change due to currency fluctuations or airline tax/fuel surcharge increases. Venue for any disputes is Dallas County, TX.
