

Terms and Conditions Footstep Ministries Tour to Israel

March 17 – March 27, 2025 \$4700 (Land Only)

This tour is based on rates in effect March 2024 and is subject to change in the event of significant currency fluctuations and/or airline tax/fuel surcharge increases. This tour is priced on a minimum of 30 paying participants.

Activity Level and Health

The activity level on this tour is moderate. Participants must be in good health and able to walk at a moderate pace, without assistance, for a couple of miles at a time on uneven terrain. Certain sites require climbing multiple flights of stairs that may not have handrails.

Included in the Price

Shared double room in first class and superior tourist hotels; daily meals as indicated in itinerary; transportation and entrance fees to sights; and gratuities.

Not Included in Price

Single room supplement: \$1,995; possible increases in the airline tax/fuel surcharge; additions/changes to standard program; individual transfers; travel insurance; coffee and drinks; excess baggage.

Airline Transportation

At this time, all travelers will secure their own airfare to Israel.

Reservation and Deposit

A non-refundable, nontransferable deposit of \$500 per person is required at the time of reservation. The balance is due no later than October 16, 2024. For reservations received after October 16, 2024, payment may also include a \$100 late booking fee per person, at the discretion of Footstep Ministries.



Transfers

Private transfers to/from the airport and hotel are available for an additional fee.

Luggage

Limit of one suitcase and one carry on per person; porterage is for one suitcase only. Carry-on luggage is the responsibility of passengers.

Cancellation Fees

Footstep Ministries must receive all cancellation and refund requests in writing. All cancellations prior to October 16, 2024 will forfeit their tour deposit; 25% of tour price is forfeited if received between Oct. 17, 2024 and Dec. 6, 2024; 75% of tour price is forfeited if received between Dec. 6 and Jan 23, 2025; and 100% of tour price is forfeited on or after Jan. 24, 2025. No-shows or cancellations after date of departure receive no refund whatsoever. All cancellation fees are based on the total tour price including any additions.

Insurance

Tour participants are highly recommended to purchase insurance for trip cancellation, trip interruption, accident, sickness and/or loss of baggage and personal effects. Travel insurance can be purchased by <u>clicking here</u>.

Documentation

U.S. citizens require a valid passport. The traveler assumes complete and full responsibility for and hereby releases FM, Inc. from any duty of checking and verifying any and all passports, visa, vaccination or other entry requirements for each destination, and all safety and security conditions during the proposed travel. **Travel to Israel requires six months of passport validity beyond the return date of the tour.**

Statement of Responsibility

If Footstep Ministries cancels the tour for any reason, payments received for the land tour are refundable in full. Footstep Ministries (FM) shall not be held responsible for any wrongful or negligent acts or omissions by any supplier or other party not directly owned or controlled by Footstep Ministries, Inc., or by the failure of any equipment operated by any such supplier or other party. FM shall not be liable for any loss, injury, or damage to person, property or otherwise, in connection with any accommodations, transportation, or other services, resulting directly or indirectly from any acts of God, dangers incident to the sea, fire, breakdown of machinery or equipment, acts of government of other authorities, wars whether or not declared, hostilities, civil disturbances, strikes, riots, thefts, pilferages, epidemics, quarantines, pandemics,



medical or customs regulations, defaults, delays or cancellations of or changes to itineraries or schedules. FM has no special knowledge regarding the hazards of medical procedures in any location, suitability of medical travel for any person, financial condition of any supplier, unsafe conditions, health hazards, weather hazards, political conditions, or climate extremes at locations to which you may travel. Neither FM nor any of its affiliates or subsidiaries shall be or become liable or responsible for any additional expenses of liability sustained or incurred by the tour member as a result of any of the aforementioned causes. FM responsibility to passengers carried in vehicles and aircraft for transfer and excursions and tours is governed by the laws of the respective countries in which the tours take place and no other country. All claims against FM must be made within 30 days of travel and are subject only to the jurisdiction of the courts of the country in which the cause of action arises. The right is reserved to substitute hotels and cruise ships and to alter itineraries. FM reserves the right to cancel the tour prior to departure. If any tour is cancelled prior to the passengers joining the tour, FM is liable for a refund of monies received. FM is not responsible or liable for defaults of those not directly under the control of FM. All tickets and vouchers issued for transportation and services are subject to the terms and conditions under which such transportation and services are provided to the participant by the owners or contractors.

The receipt of your deposit will indicate that you have read these Terms and Conditions, and that you have agreed to them. Prices are subject to change due to currency fluctuations or airline tax/fuel surcharge increases. Venue for any disputes is Denton County, TX.
